  - A member of the public inquired about sharing the sales tax with charter schools; and using the sales tax for teacher salaries.
  - Mr. Mazurkiewicz responded that the original referendum did not include language for charter schools to participate.
  - Mr. Shimp responded that teacher pay is funded from the operating portion of the budget, and funds from sales tax collections may not be used for salaries.

- Visit the website Change for Change and become familiar with the available information
- Mrs. Irma Lancaster
  - Keeping a log of communications
  - Analytics for the website
    - 10,000 views on the main page
    - Each school has about 150 views
    - Sales Tax Tuesday weekly social post that drives back to this page with causes uptick in visits
    - Average time spent on the site 2.7 seconds
  - o FGCU economic impact study
    - Research and reporting presented to the board and ISSOC this Fall
  - Signage
    - Increased signage needed at 17 locations requesting board approval
    - Specific signs at the new school locations and in parent pick up lines
    - Bigger signs coming listing with projects completed at that location
    - Using digital bill boards and student flyers sent home with the students

  - o Then completes a Build Out Study assume every available space was developed
    - This has never been done for the district in the past
  - Residential Developments
    - Cape Coral is projected to see 28% growth
    - East Zone -primary Lehigh Acres projected to see 21% growth
    - New Projects in next 5-10 years for all education levels
