





FY23 Estimated Capital Revenue - \$345.9M





FY23 Sales Tax Budget - \$205,336,333


by Sales Tax Category – September 2022

MONTHLY SALES TAX COLLECTIONS YEAR OVER YEAR BY MONTH EARNED


